Celeste welcomed the board members and those attending from the public then started the meeting with a prayer.

#### 5. Introduction of Board of Directors

Terms for 4 current Board members are up this year: Celeste, Lisa, Alyssa, Katie. Ryan has resigned from the Board due to his moving out of town and Katie will not be reoffering. Therefore, there are 5 vacant Board seats.

## 6. Overview of the accomplishments of the Food Basket for 2024

Dee Dee, Operations Manager, provided an overview of the accomplishments over the past year:

- Dee Dee introduced the Operations team: Bev Reid, volunteer coordinator; Gary Bolton, food co-ordinator and Leslie O'Brien, treasurer.
   Unfortunately, Leslie was not able to attend the meeting.
- We now operate on a 2-month rotating cycle for the items in the client offering.
- We have experienced a 13% increase in clients for 2024 over 2023.
- 2 million Canadians have visited food banks Nationally this year.
- There are presently 89 active volunteers; 10 new since January

- FDA and the local Independent have been providing weekly donations;
  we have received over 30,00 pounds of food from FDA and 1300 pounds from the Independent.
- We have received new shelving units, new busing carts and 4 new shopping carts. Floyds Appliance Store donated a new refrigerator.
- 40-43 deliveries are made to clients each month
- An evening shift (6pm-7pm) has been added to the Thursday client day to accommodate those that cannot come during the day including those that work.
- The clothing drive held in November was very successful with 140+ clients and new comers participating. Next day a promotion was held for the town residents fill a bag for \$10 which raised \$950. A spring clothing drive is under consideration.
- Hampton Food Basket is now a member of the Hampton Chamber of Commerce which provides networking opportunities and more exposure in the community.
- After The Bell promo was run again this past summer to provide extra food to the school age children.
- Community Garden continues to partner with the Food Basket and provide a large amount of fresh produce for our clients.
- Hampton Food Basket continues to be supported by many local businesses and service groups.
- National Standards are being worked on in conjunction with Food Bank Canada.
- Christmas Campaign will emphasis Cash, Cards & Cans.
- The Food Basket will be participating in a number of events running up to Christmas.

Motion made by Lisa and seconded by April to accept Operations report. Motion passed.
